# SUPERINTENDENT'S MESSAGE

Greetings from me and the Provo City School District. I hope you are having an enjoyable summer!

We issue this communique every summer to the residents of Provo in an effort to keep you informed about happenings within the school district. We try to be very careful with our finances so we don't use this medium as often as we would like. However, please be aware that Provo City School District has a website that is updated regularly (http:///provo.edu), and we have Twitter feed and Facebook page. We encourage you to check in with us regularly through any or all of these sources.



The 2015-2016 school year was an exciting, eventful year. I do not have space here to outline all of the many accomplishments, but here are a few.

- All of 13 our elementary schools received A or B school grades in the past school year. Note that some of our elementary schools have poverty rates of over 70%.
- New for 2015-2016: 3 Title I Preschools.
- Significant efforts at inclusion, including adopting possibly the state's first anti-racism procedure.
- Translation of all district policies into Spanish is underway.
- Comprehensive Annual Financial Report (CAFR) awards from GFOA and ASBO 13 years in a row, budget award from GFOA and ASBO 9 years in a row.
- Consistent awards and national recognition for the district's Child Nutrition program.
- 30% increase in AP participation at both Timpview and Provo high schools.
- 60% increase in Regent Scholars.
- High (maybe highest in state) percentage of DLI schools.
- Comparable/higher SAGE/CRT scores than much less highly impacted neighbors.
- All 2015-2016 school based administrators (and some district) fully trained and certified in the new state Teacher Evaluator Certification training.
- Implemented a new model for health clerks in elementary schools and social workers throughout the district through an innovative structure and funding.

In August we will be opening the doors of two newly reconstructed elementary schools. As I write this, construction of the new Provo High School is already underway, with the subterranean stabilizations being installed upon which the foundation of the school will be poured.

Although we had several great years in terms of student achievement and overall district improvement, our desire is to always find areas where we can increase and then, in turn, accomplish those successes as well. We take this stewardship very seriously: for our community, for our taxpayers, and especially for our students.

# **BOARD OF EDUCATION MESSAGE**

# Construction Update

#### **Rock Canyon and Sunset View**

Work continues to go according to schedule on both Rock Canyon and Sunset View. In the interior of both buildings, crews are completing work on the plumbing and electrical systems. The ceilings are being installed and preparations are being made to begin finishing work on the floors. At Rock Canyon, a chain link fence is being installed on the north side of the property along the retaining wall.

Outside, the ground is being leveled in preparation for landscaping and the installation of the parking areas. Both sites are beginning to clear up, as much of the equipment has been removed or relocated.

# WORK CONTINUES IN EARNEST ON ALL FIVE OF THE NEW SCHOOLS BEING BUILT.

Both schools are on schedule to open this school year. Teachers in the current buildings are working with district officials to pack up their current classrooms to prepare to move into the new schools this summer. More information will be coming as plans for the grand openings are finalized.

#### **Provost and Edgemont**

Work is also commencing on the new Provost and Edgemont construction plans. Unfortunately, bids on the Provost and Edgemont projects came in significantly over the proposed and anticipated

budget. After much consideration, the Provo City School District Board of Education has made the difficult decision to postpone the groundbreaking ceremonies for both Provost and Edgemont elementary schools to a later date.

In an effort to be mindful of taxpayer dollars, the Board of Education has decided to re-bid Provost later this year and move forward with Edgemont after making changes to Edgemont's design. Many factors were considered before making these decisions, including: significant construction inflation, phasing and scheduling adjustments for increased cost efficiency, etc. Moving forward, the Board of

Education is committed to fiscal responsibility and transparency as work on these projects continues.

#### **Provo High School**

On Wednesday, April 27, groundbreaking ceremonies were held at the new Provo High School location. Board members, district administrators and Mayor John Curtis addressed the crowds, followed by the ceremonial groundbreaking. Shovels and mini excavators provided by Westland Construction were used to perform the ceremony. Afterward, parents and children in attendance were invited to take turns with the shovels and the mini-excavators.

Provo City School District was pleased to have Donald and Dorothy Reese in attendance for the groundbreaking. The district received the land that the new PHS will be built on from the Reese family. It was interesting to hear the Reese's tell stories about what used to be done on the land.

Groundwork has been done on the land in preparation to begin work on the geo-pier work. This is the process of drilling into the ground and creating piers that will stabilize the future building during a seismic event.

The final site layout for the new PHS has also been announced. The building will include three, 3-story classroom wings to the east and with the gym, auditoriums, shops, media center and other rooms to the west. The main office entrance will

be located at the south end of the building. All of the athletic fields and stadiums will be located to the west and south of the main building. Work continues on the artist renderings of the façade of the building and the landscaping around the buildings. While some drawings have been released, and may provide a good example of what the school may look like, there continue to be some minor adjustments made. Once the final artist renderings are complete, they will be

released to the public.

# SCHOOL REGISTRATION INFORMATION



#### Kindergarten and New Elementary Student Registration

Pre-registration for all new students in kindergarten through sixth grade and those not previously registered will be done through the online registration system. Visit forms.provo.edu for detalied information to access the online registration.

If you are in doubt as to which school to attend, please contact Student Services at 801-374-4838 for assistance in English or Spanish, your school's office or visit the Provo City Geographical Viewer at maps.provo.org.

By state law, no student may attend kindergarten unless the child is five years old on or before September 1, 2016. Parents registering kindergarten children or new students to the district must bring an original birth certificate (not a copy), an up-to-date record of immunizations, and proof of address. Please contact your child's school to submit these documents.

#### Online Registration for New and Returning Students

Provo City School District is now utilizing an online registration system. This system will allow you to enter your demographic data for new students. You may access the online system from any place with Internet access. Visit **forms.provo.edu** for detailed instructions to access the online registration.

All returning students can access and/or update demographic data from the Parent Portal Account in PowerSchool starting August 10 through September 15. If you do not have an account, visit grades.provo.edu. Under the tab *Create Account Help* you will find step-by-step instructions.

A returning student is one that was enrolled on May 26, 2016 in a Provo City School District school. If the student was absent prior to this date they are still considered enrolled. If you withdrew your student prior to July 15, they will need to register as a new student.

#### **Centennial Middle School Information**

**New Students:** Students who have moved into the Centennial boundaries, or have been accepted on School Choice, and have not had an opportunity to fill out a preliminary class schedule, may do so on August 4-5, from 8:00 a.m. until 2:00 p.m. The following documents are required for registration: birth certificate, immunization records, and



proof of residency (mortgage or rental agreement, or a current utility bill which includes gas, power, or Provo City). Please call 801-370-4621 for more information.

#### **Dixon Middle School Information**

**Registration:** Please follow the online process outlined in this newsletter to know how this is to be done. We request that parents/guardians update/verify students' information online before school begins. Fee payment information is delivered by mail. Fees may be paid and registration finalized by mail or online through August 12.



New Students: Students who have moved into the Dixon boundaries, or have been accepted on School Choice, and have not had an opportunity to fill out preliminary class schedule may do so on August 4-5. You may come to the Library from 8 a.m. until 2 p.m. The following documents are required for class scheduling: Birth Certificate, immunization records, and proof of residency (mortgage or rental agreement, or current utility bill). Incoming 7th grade students must have a Tdap booster as well as a Varicella shot or previous history of chicken pox. Please call 801-374-4980 for more information.

**Returning Students:** Students who receive incomplete schedules in the August 3rd mailing, or are seeking to make a schedule change should visit

the counseling office beginning August 5th to complete their schedule from 8 a.m. - 2 p.m. daily.

**7th Grade Orientation:** All students new to Dixon may attend Camp Dixon on August 10th to make new friends and learn more about Dixon. Students can choose to attend a morning session from 8:30 a.m. - 11:30 a.m. or an afternoon session from 12:30 p.m. - 3:30 p.m.

Back to School Open House: August 15 from 4:00 p.m. to 6:00 p.m.

**First Day of School:** Only seventh grade students will report to Dixon on Wednesday, August 17 at 8 a.m. for a full day of school. All students will report for classes on Thursday, August 18 at 8 a.m.

**School Fees:** Please bring free/reduced lunch form filled out completely if you would like to apply for free/reduced lunch, or you can fill it out online. A free/reduced lunch form does not waive your school fees. Be prepared to pay for school fees. Registration fees this year will be \$100.00. We accept Cash, Checks or Debit or



Credit Cards. Or to apply for fee waivers, please bring the last two current pay stubs or income tax returns from the prior year.

#### **Provo High School Information**

Registration: August 8th, 9th, and 10th will be PHS Bulldog Registration Days. Students will be able to view their class schedule online through Class Choice on Monday, August 1st. Students/parents should only attend Bulldog Days if an approved schedule change is necessary and/or if you would like to pay fees at the Business Office or take care of other business items. Approved schedule changes include incomplete or incorrect



schedules (such as being enrolled in the wrong level of a class).

If online registration is complete, you may

call the Counseling Office beginning on Aug. 1st to set up an appointment.

Please bring the following items to your appointment:

- Original birth certificate (not a copy)
- Up-to-date record of immunizations. Additionally, any students enrolling in school after 6 months out of the country need to have a completed TB test and results.
- Proof of address (utility bill, housing contract, etc.)
- Transcripts from previous school

Enrollment cannot be completed without these documents. Thank you!

Early Intervention Preschool Information

PCSD is now offering a tuition based preschool located at Sunrise Preschool. Sunrise serves students with disabilities and is looking for typical peers that can model age appropriate skills. The curriculum follows the state approved standards and is an excellent learning environment with highly trained teachers and staff. The preschool is Mon-Thurs and the tuition is \$80 a month for either M/W or T/Th AM or PM sessions. Students that have turned 3 before September 1st through students that will turn 5 before September 1st, and are toilet trained and able to model good communication and behavior skills, will be eligible. For more information, please contact Sunrise Preschool.

#### **Title I Preschool Information**

The district is excited to continue offering the Title I Preschool at three locations this Fall. Locations:

- Provo Peaks Elementary will serve Provo Peaks and Timpanogos students.
- Franklin Elementary will serve Franklin, Sunset View and Amelia Earhart students.
- Spring Creek Elementary will serve Spring Creek and Provost students

Eligibility Requirements:

- Students must currently live in the boundaries of a Title I school.
- Students must be 4 years old by September 1st of the current school year.
- Students must qualify for the program through academic testing (at-risk students will have priority placement).

If you are interested in having your child assessed, please contact the Title I Office at 801-370-4616.

#### Fee Waivers

Fee Waiver Applications are available at: www.schools.utah.gov/law/Forms.aspx Parent(s)/guardian(s) shall provide income eligibility documentation in the form of income tax returns or current pay stubs demonstrating compliance with requirements. Fee Waiver applications and income documentation should be turned in to the middle school and/or high school that the student(s) attends. Fee Waiver eligibility is determined at the school site. See Fee Waiver Application for more details.

#### **Immunizations**

Utah law requires that school records include complete immunization records. Records must include documentation of the day, month and year for each immunization.

#### **Kindergarten Entry Requirements**

The following vaccines are required for students entering Kindergarten:

- 5 DTP/DTaP/DT 4 doses if 4th dose was given on/after the 4th birthday
- 4 Polio 3 doses if 3rd dose was given on/after the 4th birthday
- 2 Measles, Mumps, Rubella (MMR)
- 3 Hepatitis B
- 2 Hepatitis A
- 2 Varicella (Chickenpox) history of disease is acceptable, parent must sign verification statement on school immunization record

#### First to Sixth Grade Entry Requirements

The following vaccines are required for students entering 1<sup>st</sup> through 6<sup>th</sup>:

- 5 DTP/DTaP/DT 4 doses if 4th dose was given on/after the 4th birthday
- 4 Polio 3 doses if 3rd dose was given on/after the 4th birthday
- 2 Measles, Mumps, Rubella (MMR)
- 3 Hepatitis B
- 2 Hepatitis A
- 1 Varicella (Chickenpox) history of disease is acceptable, parent must sign verification statement on school immunization record

# Additional Seventh Grade Entry Requirements (must have K - 6<sup>th</sup> grade requirements)

The following vaccines are required for students entering seventh grade (these are in addition to elementary grade requirements):

- 1 Tdap
- 2 Varicella (Chickenpox) history of disease is acceptable, parent must sign verification statement on school immunization record
- 1 Meningococcal

#### Additional Eighth to Twelve Grade Entry Requirements (must have K - 6<sup>th</sup> grade requirements)

The following vaccines are required for students entering 8<sup>th</sup> through 12<sup>th</sup> grade (this is in addition to elementary grade requirements):

• 1 Tdap

State law requires that students with incomplete immunization records be excluded from school. If the school does not have this record, please send this information to your child's school. If you have questions concerning the requirements, call the Utah County Health Department at 801-851-7025. For complete immunization rules, please refer to the School Utah Immunization Guidebook that can be found at www.immunize-utah.org.

#### Family Educational Rights Privacy Act

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age the right to inspect education records, the right to request amendments to records which are believed to be inaccurate, the right to consent to disclosures of non-public personal identifiable information, and the right to file a complaint regarding FERPA issues. If you have a request or concern, or would like a complete disclosure statement of your rights under FERPA, please contact your school principal or visit our website at studentservices.provo.edu

#### **Open Enrollment – School Choice**

Parents interested in having their students attend a different school than their boundary school are required to fill out an application. Applications are available in the Student Services office or online at studentservices.provo.edu.

Open enrollment begins Dec.1<sup>st</sup> and closes the 3<sup>rd</sup> Friday in February. Notification of acceptance or rejection is sent by March 31<sup>st</sup>. Please note that it is against State Law to have waiting lists. Applications do not forward from year to year.

#### **Education for Students with Disabilities**

Provo City School District offers a variety of educational programs and support services designed to help children who are in need of special education and related services or Section 504 supports. If you suspect your child may have a disability that affects his/her ability to learn, please notify your local school. You may also contact the Provo City School District Special Education Office at 801-374-4933 or the Student Services Office for Section 504 support at 801-374-3814.

#### Provo eSchool

Provo eSchool is Provo City School District's online school. We offer a large variety of courses, including world language starting as young as third grade! Students in grades K - 12 may enroll full-time at eSchool or they may dual enroll with another school in the district. Full-time students should fill out the forms available on our website.

Dual-enrolled students must receive counselor approval before including eSchool courses in their schedule. eSchool classes are part of a student's schedule, they are not supplemental. To learn more please visit: eSchool.provo.edu or e-mail us at eschool@provo.edu.

#### Transportation

School bus routes for the 2016-2017 school year will be posted on August 1st.

Please check as buses, times or stop locations may have changed. To find bus route information search under the For Parents drop down tab at provo.edu or your schools website and click on the Bus Stops link. Please refer to the district website throughout the year for information pertaining to school bus transportation. Please remember that walk zones are 1.5 miles

for elementary schools and 2 miles for secondary schools. Per state standards, if you live at or under that distance, you do not qualify for transportation. Students may only ride their assigned bus as per district policy 6605 P1. All transportation policies may be found on the district website.



# THE PROVO WAY INNOVATIVE LEARNING INITIATIVE SOARS!

The Provo Way Innovative Learning Initiative is a strategy used by the Provo City School District to produce students who can thrive in a technology-rich society with the skill of being able to problem-solve with high quality solutions. Data has shown there is a positive correlation between schools that have adopted the Innovative Learning Initiative and learning.

During the 2015-16 school year, the Provo Way Innovative Learning Initiative more than doubled in size. The Initiative expanded from 32 classrooms to 70 classrooms. We expect to continue expansion to 110 classrooms during the 2016-17 school year. This will add roughly 2,100 students to the Initiative this year, bringing our total student involvement to about 7,600 students, about half of our student population.

To implement this program, our teachers attend weekly meetings to receive training in research-based teaching strategies. In addition to

the weekly trainings, our teachers also attended several different conferences learning teaching strategies, technological advancements and integration techniques. They are truly professionals and are given the freedom to use their professional judgment to help each of their students achieve their highest potential.

One extraordinary educator recently summed up this concept when she said, "all spoon-feeding of ... answers must stop! Teachers, please toss your spoon in the trash and hand your student a shovel! They need to dig for answers too."

Because of this newly implemented initiative, our students are learning to think, reason and solve problems creatively and independently.

We want our students to become more than just consumers of the education they are given. We expect our students to become producers, not only of their own education, but also in society.






