SUPERINTENDENT'S MESSAGE

As I write this summer newsletter message (early June), school has been out for almost two weeks, graduations were adjusted and held, and somehow we made it. Since the Governor's announcements about school responses to COVID-19 that started on March 13 (and then were adjusted during April and May) it has been a very complicated time for students, parents, teachers, district staff, and administration, not to mention businesses around the country. Like you, employees throughout the district have struggled to make sense of the many inconsistencies, contradictions, and moving targets regarding the right and best actions to ensure safety.

I am grateful beyond words for the many kind expressions that have been sent to me, sharing appreciation for dedicated and caring teachers, our responsive technology staff, food service workers, school administrators, counselors, and so many others who have worked so hard to maintain some degree of normalcy during this unprecedented time in our society. As I mentioned in a tweet (Twitter handle @PCSDSupt) a few weeks ago, there is no manual, no course in any education degree program I am aware of to

prepare us for how to manage this pandemic and its impact on education, educators, and students. We have tried (and continue to try) to employ good sense and logic to the challenges that arise. I also would like to extend my appreciation to district and school staff for working so diligently to clearly communicate over the last many weeks. Families and employees have been anxious to know what was next, and very dedicated staff throughout the district have tried to reassure and clarify.

I recently saw the following, humorous post.

Meetings nowadays feel like this: "We don't know much.

What we do know we really cannot tell you because everything is going to change.

Given the above, you need to make a good, defensible plan."

We are navigating through this changing landscape to figure out what happens next when we return to school in mid-August. I have heard through the channels available to me as superintendent, that we could be in a "business as usual" posture, a yellow model requiring social distancing and therefore some modifications to normal school settings, or some other variant. Even though I have the authority to close schools due to weather, I do not have the authority to close schools due to illness of students/staff. We continue to work with Health Departments, the Utah State Board of Education, and other State officials as they provide direction in this matter.

It was somewhat of a relief that we made it through the 2019-2020 school year. I felt great empathy for the graduating students, along with the teachers who have made the decision to retire this past June due to concerns about their health, the economy, etc.. I have regularly referred to the Class of 2020 as "The Class of Resilience." This graduating class had a significant portion of their Senior year upended in terms of their anticipated celebrations and ceremonies. The coming months also pose some uncertainties regarding next steps in their own individual life routes. Nevertheless, the students adapted and overcame. My hope is that they will continue to show resilience in response to the inevitable challenges they will encounter. As for the teachers, I know they did not expect this kind of an ending to their careers. I appreciate that they were genuine professionals to the end.

I hope you are looking forward to the coming school year. I expect to have written guidance published later in July that will answer questions about any system or educational delivery changes for 2020-2021. We are hoping for a return to normalcy. Please join us in Provo City School District to make it a tremendously successful year for our students and staff.

BOARD OF EDUCATION MESSAGE

As we look forward to beginning the next academic year, we will do so with a "new normal". Much of what we have learned over the last three and a half months will help. However, we will almost certainly face some new unexpected challenges and opportunities. In planning and preparing for next year, we will continue to focus on meeting the needs of students, faculty, staff, and community. We will, among many things, determine how to most effectively address the "three phases on the path to recovery and our new future" as identified by the Utah State Board of Education.

Phase One

- Continue providing learning opportunities for all students
- Provide graduating seniors the content they need to transition
- Maximize opportunities for students to continue to receive meal services
- Make every effort to keep staff gainfully employed
- Support student and staff mental health and social emotional needs

Phase Two

- Determine how federal funds, including CARES Act funds, may be used to fund summer learning
- Use formative assessments to determine gaps in learning
- Provide opportunities for small group and individual tutoring
- Develop and implement digital opportunities for review and catch up

Phase Three

- Use assessments as a formative tool in the fall to assess learning gaps and set baselines for the 2020-2021 school year
- Continue providing opportunities for small group and individual support
- Apply lessons learned from remote instruction to inform methods for personalizing instruction and validating learning that occurs outside the classroom

We realize that as we implement these phases of reopening and restrictions that there will most likely be changes to these phases over time.

While our change from traditional instructional strategies and activities to an online instructional environment was not without challenges, we did a remarkable job. Among our successes, we found a new way to celebrate high school graduation. We found a renewed commitment to reaching out to the one, whomever the one was.

I have been told of countless acts of kindness, sensitivity, generosity, and sacrifice on the part of district employees. I have been impressed by the willingness of everyone to try new things and to consistently strive to put the needs of others before self. I express my heartfelt gratitude and thanks to all who are employed by the Provo City School District and make it such an incredible organization to work for.

Online Registration for Returning Students

Provo City School District utilizes an online registration system. This system will allow you to enter your demographic data for new students. You may access the online system from any place with Internet access. For detailed instructions on how to access the online registration, visit grades.provo.edu and click on the "New Student Registration" tab.

All returning students can access and/or update demographic data from the Parent Portal Account in PowerSchool starting August 10 through September 15. To create a Parent Account, please contact one of your children's School Registrars. They can help you create the parent account and attach your children to it.

A returning student is one that was enrolled on May 24, 2019 in a Provo City School District school. If the student was absent prior to this date, they are still considered enrolled. If a student was withdrawn prior to July 15, they will need to register as a new student. Please contact either Student Services at 801-374-4838 for assistance in both English and Spanish, or your school's office.

Online Registration for New Students and Kindergartners

Pre-registration for all new students in kindergarten through sixth grade, and those not previously registered, will be done through the online registration system. Visit grades. provo.edu for detailed information to access the online registration.

If you are in doubt as to which school to attend, please contact Student Services at 801-374-4838 for assistance in English or Spanish, your school's office or visit the Provo City Geographical Viewer at https://provo.edu/school-boundary-locator/.

By state law, no student may attend kindergarten unless the child is five years old on or before September 1, 2019. Parents registering kindergarten children or new students to the district must bring an original birth certificate (not a copy), an up-to-date record of immunizations, proof of address, and a photo ID. Please contact your child's school to submit these documents.

Title I Preschool Information

The district is excited to continue offering Title I Preschool at four locations this Fall. The preschool classes are currently full for this school year.

However, screening for possible placement/waiting list will continue throughout the year; often times there is movement and spots become available.

- Provo Peaks Elementary will serve Provo Peaks and Timpanogos students
- Franklin Elementary will serve Franklin students
- Spring Creek Elementary will serve Spring Creek and Provost students
- Sunset View Elementary will serve Sunset View and Amelia Earhart students

Eligibility Requirements:

- Students must live in the boundary of a Title I school
- Students must be 4 years old by September 1 of the current school year
- Students qualify for the program though a screening process; students who are most at-risk of meeting standards will have priority placement

Fee Waivers

Fee Waiver Applications are available at:
https://www.schools.utah.gov/policy/resources
Parent(s)/guardian(s) shall provide income eligibility
documentation in the form of income tax returns or current
pay stubs demonstrating compliance with requirements. Fee
Waiver applications and income documentation should be
turned in to the middle school and/or high school that the
student(s) attends. Fee Waiver eligibility is determined at
the school site. See Fee Waiver Application for more details.

Immunizations

Utah law requires that school records include complete immunization records. Records must include documentation

of the day, month and year each immunization was given.

Kindergarten to Fourth grade requirements For students entering Kindergarten:

- 5 DTP/DTaP/DT 4 doses if 4th dose was given on/ after the 4th birthday
- 4 Polio 3 doses if 3rd dose was given on/after the 4th birthday
- 2 Measles, Mumps, Rubella (MMR)
- 3 Hepatitis B
- 2 Hepatitis A
- 2 Varicella (Chickenpox) history of disease is acceptable, parent must sign verification statement on school immunization record

Fifth to Sixth Grade Entry Requirements For students entering 5 through 6:

- 5 DTP/DTaP/DT 4 doses if 4th dose was given on/ after the 4th birthday
- 4 Polio 3 doses if 3rd dose was given on/after the 4th birthday
- 2 Measles, Mumps, Rubella (MMR)
- 3 Hepatitis B
- 2 Hepatitis A
- 1 Varicella (Chickenpox) history of disease is acceptable, parent must sign verification statement on school immunization record.

Additional Entry Requirements for Seventh to Eleventh Grades (must have K - 6 grade requirements)
For students entering seventh grade (these are in addition to elementary grade requirements):

- 1DTap
- 2 Varicella (Chickenpox) history of disease is acceptable, parent must sign verification statement on school immunization record.
- 1 Meningococcal

Additional Twelfth Grade Entry Requirements (Must have K - 6 grade requirements)

- 1 Tdap
- 1 Varicella (Chickenpox) only.

State law requires that students with incomplete immunization records be excluded from school. If the school does not have this record, please send this information to your child's school. If you have questions concerning the requirements, call the Utah County Health Department at 801-851-7025. Exemptions All Kindergarten, 7th grade and new students to the District who claim a medical, personal, or religious immunization exemption must complete an online module available AFTER July 1, 2020 at immunize-utah.org.

Open Enrollment – School Choice

Parents interested in having their students attend a different school than their boundary school are required to fill out an application. Applications are available online at https://provo.edu/stu-dent-services/open-enrollment/. The early enrollment window for open enrollment begins Dec.1 and closes the third Friday in February. The late enrollment

window begins the fourth Monday in February and remains open until the programs are full. Notification of acceptance or rejection for the early enrollment period is sent by March 31. Notifications for the late enrollment period are sent as room becomes available but it can take up to the Friday



before school starts. Please note that it is against state law to have waiting lists. Applications do not forward from year to year. If you have any questions, please contact 801-374-4838.

Education for Students with Disabilities

Provo City School District offers a variety of educational programs and support services designed to help children who are in need of special education and related services or Section 504 supports. If you suspect your child may have a disability that affects his/her ability to learn, please notify your local school. You may also contact the Provo City School District Special Education Office at 801-374-4933 or the Student Services Office for Section 504 support at 801-374-4814.

Provo eSchool

Provo eSchool, Provo City School District's accredited online school, is entering its 10th year of helping students access a quality education with the flexibility a virtual environment provides. Students in grades K-8 may enroll full-time, which includes four core courses (math, language arts, science, social studies) and 1-2 electives depending on their grade level. The curriculum is from K12, a nationwide online curriculum provider and is provided free of charge, although families are responsible to have their own computer and internet. A learning coach, who is usually the parent/quardian, guides their student(s) through their daily instruction and tasks which are outlined by K12. An experienced, licensed PCSD teacher is available to support parents and students with content and the K12 system. Students in grades 1-8 may also dual enroll with another school in the district. High school students may enroll in up to four courses online while taking their other four courses at their local high school. They must receive counselor approval (as a signature on the eSchool enrollment form) in order to include eSchool courses in their schedule. High school courses—both original credit and credit recovery are provided through BYU Independent Study curriculum. High schoolers wishing to take all online classes may be granted an exception to the four-course rule with permission from both school and district administration. Application Procedures for Dual Language Immersion (DLI)

The Dual Language Immersion program is available in Mandarin Chinese, French, Portuguese, and Spanish. The program seeks to enroll students of varying backgrounds and all ability levels. Applications are open to all students entering 1st grade. The submission of the applications for the 2021-2022 school year will start Dec. 1, 2020 and ends on the third Friday in February for the early enrollment period. The late enrollment period will begin the fourth Monday in February and remain open until all the programs are full. Applications will be processed in the Student Services Office. Detailed information will be posted on our website and mailed out to all parents of enrolled Kindergarten students in November. Our district strongly supports every student in their need to be happy, healthy, and ready to learn. Meal Charging Policy 6710 P1 is implemented to ensure students have access to meals at school even if they do not have money in their lunch account or in hand to pay. Our online application process is successful and a preferred method of applying for the Free and Reduced program. We will accept online applications for the new school year starting July 27th via www. schoollunchapp.com. Links will be available on district and school websites, and following online student registration steps. Maintaining fiscal responsibility, breakfast and lunch prices will remain the same for school year 2020/2021. Reduced prices: breakfast is \$.30 and lunch is \$.40. Full pay prices: breakfast K-12 is \$1.50; elementary lunch is \$2.00 and secondary lunch is \$2.25. Adult prices: breakfast is \$2.00 and lunch is \$4.00.

Transportation

School bus routes for the 2020-21 school year will be posted on August 1. Please check as buses, times or stop locations may have changed. To find bus route information search under the "For Parents" drop down tab at https://provo.edu or your school's website and click on the Bus Stops link. Please refer to the district website throughout the year for information pertaining to school bus transportation. Please remember that walk zones are 1.5 miles for elementary schools and 2 miles for secondary schools. Per state standards, if you live at or under that distance, you do not qualify for transportation. Students may only ride their assigned bus as per district policy 6605 P1. - Purchasing additional tools and chemicals to ensure that our Custodial teams have scientifically validated equipment and chemicals, and are utilizing industry-leading methods to best clean and disinfect our schools.
- Increasing our focus on disinfecting high touch surfaces or fomites-which are areas of possible cross-contamination. Provo City School District Custodial teams target these areas using a hospital-grade, EPA registered disinfectant that has been verified by the CDC to be effective against Sars-CoV-2, the virus that causes COVID-19.

Thank you to all of our Custodial team members for their extra efforts this summer! We look forward to providing the ongoing health and cleanliness standards you expectfor the students, teachers, and patrons of Provo City School District.

SPECIAL EDUCATION HIGHLIGHTS

One of the six principles of the Individuals with Disabilities Education Act (IDEA) is parent involvement. During the 2019/2020 school year, we focused on this principle by skilling up our special educators' capacity to communicate and empathize more effectively with families as we provide a free appropriate public education (FAPE) to each child with a disability. We invited parents to share their journey with us about raising children with special needs and we discussed ways to improve communication. The Utah Parent Center facilitated parent panels and helped us hold a parent night this past February to share resources in our district and community that support children with special needs. Due to schools being closed for in-person services because of COVID-19, parent involvement was imperative and we relied upon communication and empathy as we partnered with you in the delivery of distant special education services to your child.

This coming school year we will focus on NARROWING the gap between students with disabilities and their typical peers in three areas:

- 1. Participation in the general education classroom and statewide assessments in language arts and math,
- 2. Proficiency on statewide assessments in language arts and math, and
- Graduation rates.

Guidance and training for school teams will occur this coming school year. We have placed a special education teacher leader at every school that will teach part-time and assist in ensuring this focus.

Now let's turn our attention to the provision of special education services and the challenges imposed by COVID-19. The health and well-being of every family and our employees are our first priority. Efforts to tailor instruction for students with special needs during the

pandemic was a complex challenge. Special education teachers and related service providers offered a distance learning plan (online instruction, packets, and/or training for parents, etc.) to every student with special needs. Despite our attempts, some students didn't participate; regardless, we withhold judgement and we celebrate each family's effort

Our focus this summer and fall is to re-engage services safely in-person with your children with IEPs. Over the summer:

- We are conducting in-person comprehensive evaluations that were delayed due to COVID-19.
 Please contact your child's SpEd teacher to schedule an appointment.
- We are offering in-person and virtual extended school year services for students who qualify. Please reach out to your child's SpEd teacher for more information.
- We are planning how schools will conduct assessments to determine the extent of learning loss (if any) that occurred for children with disabilities during March thru May 2020.
- We are exploring options to provide in-person and/or virtual recovery services that will be available for your child with an IEP. More information coming.

PCSD is inviting parents to provide input through a survey as we make plans to open school in the fall. We will continue to practice flexibility and understanding in supporting students with IEPs. We are optimistic about the future.

What is Child Find?

PCSD is responsible for the identification and evaluation of students suspected of having a disability residing in Provo. If you suspect your child may have a disability and may be eligible for special education services under IDEA, please contact your neighborhood school or the Provo City School District Special Ed Office at 801-374-4933. What is a Comprehensive Evaluation?

After obtaining written consent from parents, PCSD has 45 school days to conduct a free comprehensive evaluation that consists of multiple data sources from standardized assessments, data from classroom based measurements, input from education professionals and input from parents. Once completed, a team of educators with the parent review all data and must answer all three questions in the affirmative for the student to qualify for IEP services:

- 1. Does the student meet one or more of the disability categories authorized under IDEA?,
- 2. Does the student's identified disability adversely affect education?, and
- B. Does the student require specially designed instruction?









GENERAL FUND REVENUE SOURCES


This graphic presents the sources of our revenue in the General Fund. In other words, where our operating income comes from.

TAX RATE BY ENTITY





PROVO KINDNESS: CELEBRATING 5 YEARS



Every school in the district has a Kindness Club for the purpose of having students learn to lead out on kindness efforts in their school. Clubs meet either weekly or bi-weekly with three main purposes:

- Increase the culture of kindness school-wide:
 This includes making posters and other visuals to create an atmosphere of kindness, as well as involving the entire school in several projects each year that help everyone remember to be more kind.
- Focus on one-on-one acts of kindness: Each club member is encouraged to look for someone who is lonely or otherwise needs a friend. Each week each student sets a personal goal for individual outreach.
- Personal growth: The social workers and parent volunteers who lead the clubs spend time each month on character-building lessons. Students learn about empathy, compassion, leadership, friendship skills, and more.

Our theme has been "Kindness Is Cool." These are just a few of the many wonderful things our Kindness Clubs did this past school year:

Amelia Earhart students set a goal to accomplish



500 acts of kindness. Students wrote down acts of kindness they performed and put them in a box to be counted.

- Every Wednesday, the Canyon Crest kindness students planned a structured recess game for everyone to join. A staff member shared, "Everyone knew that Wednesdays were a day to play with someone new. It was fun to see the new connections made."
- Edgemont students created sticky notes with written affirmations that they posted on their school walls. They hung them all over the school and students could pick a note off the wall to keep for themselves or share with someone else.
- Provo Peaks students made an effort to get to know the new students in their school through welcoming tours.
- Westridge students conducted a Kindness Countdown. Using an advent-type calendar, classrooms were challenged to perform a different act of kindness each day.
- Provo High students performed a sticky note affirmation activity, making sure that the teachers also benefited from kind words.
- Timpview High students created three projects based upon the Golden Rule that would improve



the culture of kindness at Timpview. Each group's project was targeted to recognize a group that they felt was underappreciated or underrepresented.

 Club members at Lakeview, Rock Canyon, and Spring Creek built an "I Can Be Kind" photo opportunity for all students. Each kid stood in as the "i" in the word "kind" on the large poster.

TIMPVIEW PHASE 1 REPLACEMENT BOND

This November, Provo City School District Board of Education will ask voters to consider a bond for \$80 million to complete the first phase of a rebuild of Timpview High School. The school board has sought input from various building experts to understand the needs at Timpview. The conclusion of this study is that Timpview is in a condition of continued deterioration. The proposed bond is to ensure that existing deterioration does not proceed to a point where the building is no longer safe. The most highly affected areas will be addressed in a way that allows students to continue to occupy the building. The district has worked closely with State Risk Management and multiple engineers to ensure that students and employees are not in a building that poses a serious risk to health and safety. The included plans outline the work that would be done on each phase of this project.

PROVO CITY SCHOOL DISTRICT'S FINANCE OFFICE EARNS NATIONAL RECOGNITION FOR DISTRICT ANNUAL FINANCIAL AND BUDGET REPORTS

Annually for 17 years, the Governmental Finance Officers Association (GFOA) and the Association of School Business Officials (ASBO) have awarded Provo City School District's Finance Department the Certificate of Achievement for Excellence in Financial Reporting for the Comprehensive Annual Financial Report. The finance department has also been awarded the Meritorious Budget Award for 12 consecutive years by both associations, as well as the Award for Outstanding Achievement in Popular Annual Financial Reporting for nine years.

These awards represent the highest recognition for school district and government financial and budget operations and reporting offered by ASBO and GFOA.



The recognition is only presented to school and government systems that have met or exceeded the standards of the programs, including an unqualified (clean) audit opinion.

PROVO CITY SCHOOL DISTRICT'S DRIVERS ED. PROGRAM

Provo City School District's Drivers Ed. program has been restructured and changes took effect at the start of the 2019 – 2020 school year. Students will have two options, a brick and mortar (traditional classroom) or an online (Canvas) course. Our program consists of four phases; students must complete the following:

- 1. Course instruction, brick and mortar (28 hours) or online (30 hours);
- 2. Simulator, two (2) hours a day for three (3) days;
- 3. Road, two (2) hours a day for three (3) days;
- 4. 40 hours of driving that is supervised by a parent, this should be done prior to enrolling.

FEES AND REGISTRATION

- \$140.00 for the class and behind-the-wheel
- \$100.00 if the student only needs behind-the-wheel
- Registration and payment will occur through the financial office at your school
- Students must register and pay for Drivers Ed. the month before the class begins
- Students who qualify for a fee waiver will not be required to pay for Drivers Ed.

ONLINE CLASS (Canvas)

- Ten (10) sessions scheduled throughout the school year
- New class begins each month and the student has 30 days to complete
- Begins on the first day of each month and ends on the last day of the month
- Mandatory face-to-face session the first Tuesday of each class from 2:30 – 4:00 p.m.
- Students will need to have their final proctored by the instructor
- Students will receive a Pass/Fail grade
- Zero Fatalities presentation is a required portion of the class

BRICK AND MORTAR CLASS

(Traditional)

- Four (4) sessions throughout the school year, one each quarter
- Class will be held Tuesday Friday from 2:30 4:30 p.m.
- Final will be proctored by your instructor

- Students will receive a Pass/Fail grade
- Zero Fatalities presentation is a required portion of the class

SIMULATORS

- Simulator schedule will be Tuesday Friday from 2:30 to 4:30 p.m.
- A student signs up for the simulator portion and it is for three days
- Must attend for three days

BEHIND-THE-WHEEL

- · Each student is assigned a road instructor
- Road instruction will occur two hours a day for three days
- Last 30 minutes of the third day will be for the road test

Notification of Rights under FERPA for Elementary and Secondary Schools

The Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

1. The right to inspect and review the student's education records within 45 days after the day the School receives a request for access.

Parents or eligible students should submit to the school principal [or appropriate school official] a written request that identifies the records they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

2. The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

Parents or eligible students who wish to ask the School to amend a record should write the school principal [or appropriate school official], clearly identify the part of the record they want changed, and specify why it should be changed. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

3. The right to provide written consent before the school discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent.

One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official is a person employed by the school as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board. A school official also may include a volunteer or contractor outside of the school who performs an institutional service of function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, medical consultant, or therapist; a parent or student volunteering to serve on an official committee, such as a disciplinary or grievance committee; or a parent, student, or other volunteer assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

Upon request, the school discloses education records without consent to officials of another school district in which a student seeks or intends to enroll, or is already enrolled if the disclosure is for purposes of the student's enrollment or transfer.

4. The right to file a complaint with the U.S. Department of Education concerning alleged failures by the School to comply with the requirements of FERPA. The name and address of the Office that administers FERPA are:

FERPA permits the disclosure of PII from students' education records, without consent of the parent or eligible student, if the disclosure meets certain conditions found in §99.31 of the FERPA regula-

tions. Except for disclosures to school officials, disclosures related to some judicial orders or lawfully issued subpoenas, disclosures of directory information, and disclosures to the parent or eligible student, §99.32 of the FERPA regulations requires the school to record the disclosure. Parents and eligible students have a right to inspect and review the record of disclosures. A school may disclose PII from the education records of a student without obtaining prior written consent of the parents or the eligible student –

- To other school officials, including teachers, within the educational agency or institution whom the school has determined to have legitimate educational interests. This includes contractors, consultants, volunteers, or other parties to whom the school has outsourced institutional services or functions, provided that the conditions listed in §99.31(a)(1)(i)(B)(1) (a)(1)(i)(B)(2) are met. (§99.31(a) (1))
- To officials of another school, school system, or institution of postsecondary education where the student seeks or intends to enroll, or where the student is already enrolled if the disclosure is for purposes related to the student's enrollment or transfer, subject to the requirements of §99.34. (§99.31(a)(2))
- To authorized representatives of the U. S. Comptroller General, the U. S. Attorney General, the U.S. Secretary of Education, or state and local educational authorities, such as the State educational agency in the parent or eligible student's State (SEA). Disclosures under this provision may be made, subject to the requirements of §99.35, in connection with an audit or evaluation of Federal or State supported education programs, or for the enforcement of or compliance with Federal legal requirements that relate to those programs. These entities may make further disclosures of PII to outside entities that are designated by them as their authorized representatives to conduct any audit, evaluation, or enforcement or compliance

activity on their behalf. (§§99.31(a) (3) and 99.35)

- In connection with financial aid for which the student has applied or which the student has received, if the information is necessary to determine eligibility for the aid, determine the amount of the aid, determine the conditions of the aid, or enforce the terms and conditions of the aid. (§99.31(a)(4))
- To State and local officials or authorities to whom information is specifically allowed to be reported or disclosed by a State statute that concerns the juvenile justice system and the system's ability to effectively serve, prior to adjudication, the student whose records were released, subject to §99.38. (§99.31(a)(5))
- To organizations conducting studies for, or on behalf of, the school, in order to: (a) develop, validate, or administer predictive tests; (b) administer student aid programs; or (c) improve instruction. (§99.31(a)(6))
- To accrediting organizations to carry out their accrediting functions. (§99.31(a)(7))
- To parents of an eligible student if the student is a dependent for IRS tax purposes. (§99.31(a)(8))
- To comply with a judicial order or lawfully issued subpoena. (§99.31(a) (9))
- To appropriate officials in connection with a health or safety emergency, subject to §99.36. (§99.31(a)(10)
- Information the school has designated as "directory information" under §99.37. (§99.31(a)(11))



Notice for Directory Information

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that Provo City School District, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Provo City School District may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Provo City School District to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with three directory information categories - names, addresses and telephone listings - unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Provo City School District to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing. Provo City School District has designated the following information as directory information: [Note: an LEA may, but does not have to, include all the information listed below.]

- Student's name
- Address
- Telephone listing
- Electronic mail address
- Date and place of birth
- Grade level
- Dates of attendance
- Photograph
- Weight and height of members of athletic teams
- Degrees, honors, and awards received
- Major field of study
- The most recent educational agency or institution attended
- Participation in officially recognized activities and sports

To opt out of having your student's directory information, photos or video disclosed for this school year, a request must be received by September 15 or within the first 5 calendar days of enrollment.

Signed requests are required annually
