Fitness of Child and Inherent Risks. To the best of my knowledge and belief, my child is
healthy, physically fit, and has been sufficiently trained to participate in the event. In the event
this changes at any point, I will immediately inform the school and withdraw my child from
further participation in the event. I understand and acknowledge that participation in the event
carries with it the potential for death, serious injury (including both short and long-term
disability), and property loss. The risks include, but are not limited to those caused by or
associated with facilities, extreme weather, temperature, condition of athletes or other
participants, equipment, travel, and the negligent or intentional actions of others, including, but
not limited to: participants, volunteers, coaches, event monitors, spectators, and
producers/sponsors. I further acknowledge that unforeseen and unknown risks may exist of
which I have do not know and I have not been apprised given the inherent risk and danger of the

Consent and Authorization for Medical Treatment. I hereby consent to my child's participation in this event, and I expressly authorize the sponsoring/organizing entities and the Provo City School District and its employees, volunteers, representatives, and agents ("PCSD") to provide and/or authorize medical treatment for my child if my child is injured or otherwise becomes ill during this event. I further waive any rights of subrogation as to PCSD and the sponsoring/organizing entities.

**Waiver, Release of Liability, Hold Harmless.** In consideration for allowing my child to participate in the event, I hereby waive any claims or rights that I may have as child's parent/guardian pertaining to my child's death, disability, personal injury, property damage, arising out of or related to the event on behalf of my child, my family, and myself, and I hereby release and

hold harmless the following entities and persons from all claims that may accrue to me, due to this event: the District, together with its directors, officers, employees, volunteers, representatives, and agents. This release includes, but is not limited to: all claims or causes of action whether based on tort, contract, or any other theory of recovery which I or my child may have or may hereafter accrue.

**Application and Acknowledgment.** I acknowledge that this Release will be used by the District and the event holders, sponsors, and organizers of the event, in which my child will participate.
